## Terms & Conditions

Camps 'R' Us, New York LLC may enroll my child for the 2022 summer camp season as indicated on this camper application. The cost for the summer of 2022 will be based on the selection of weeks and days, as set forth in the fee schedule located at [www.campsrus.org/sessions-fees/](http://www.campsrus.org/sessions-fees/) and page one (1) of this camper application.

All camp fees are due on or before April 1, 2022 (or within 5 business days of enrollment after April 1, 2022) unless you selected a monthly installment payment plan. A \$300.00 non-refundable deposit per camper must be paid at the time of enrollment. If camp fees are not paid in full per the billing preference/payment schedule on page 3, all discounts will be forfeited and enrollment will be cancelled with no refund. In the event of delinquent payment, I agree to pay all costs incurred during the collection process, including legal fees and interest. Check, eCheck, Debit Card or Credit Card payments that are returned to Camps 'R' Us after deposit for any reason will incur a \$45.00 service fee. Monthly installment payments not received within 10 business of the due date will incur a \$45.00 late fee.

Camp fees (not including the \$300 deposit) are refundable until April 1, 2022. Camps 'R' Us reserves the right to charge an administrative fee up to \$300 per camper in addition to the non-refundable deposit for costs incurred as a result of enrollment. After April 1, 2021, **no refunds will be made for any reason** including, but not limited to, camp closings, absences, changes, transportation delays, withdrawals or termination. If a camper is absent for documented medical reasons for more than 5 consecutive camp days, the camper's enrollment may be adjusted as follows: for days missed after the first 5 consecutive missed days, the total number of weeks enrolled may be reduced to the nearest full week. A pro-rated credit may be offered based on the difference in price between the original enrollment and the adjusted enrollment; a physician's note must be submitted. **Positive COVID-19 cases and quarantine orders resulting from an exposure to a positive COVID-19 case are excluded from the 5-day medical deductible, and are not eligible for a credit or refund. There are no make up days for absences for any reason.** Camp is closed July 5, 2021. Changes made to your enrollment after your initial camper application for the 2021 camp season will be priced as follows: Additional weeks or days added to your original enrollment will be priced at the rate in effect at the time the additional weeks or days are added. Weeks or days removed from your original enrollment will be credited based on the rate that was in effect when your initial camper application was received.

For the safety and general welfare of all campers, Camps 'R' Us, New York LLC reserves the unrestricted right, at its sole discretion, to terminate this enrollment agreement and dismiss a camper, whose conduct or influence, in the opinion of the Camps 'R' Us Administration, is inimical to the best interests of Camps 'R' Us, New York LLC. In the event of such termination, Camps 'R' Us, New York LLC is not obligated to refund camp fees or any unused amount of the camp fees.

Permission is hereby granted to Camps 'R' Us, New York LLC for my child to participate in all camp activities, and to take my child by bus and or walking on trips off campus as part of any Camps 'R' Us program. Permission is hereby granted for the camper to participate in water-related activities, including trips to the Nassau or Suffolk County Pool Facilities listed below, and water-related venues that are not inspected by the Nassau County Department of Health, or Suffolk County Department of Health Services or any other organization or municipality to which campers may travel. I understand that the Camp Directors have selected the venues and activities, which they have determined to be safe and suitable for campers, and that camp staff will verify the safety of each site at the time that the camp group visits. I understand that my child is responsible for his/her behavior at all times. If in the view of the trip leader conducting the trip, my child becomes involved in behavior that presents a danger to him/herself, other children, or staff, appropriate steps will be taken to protect all parties.

Permission is hereby granted for my child to apply sunscreen to him/herself while at camp, or to receive assistance from a Camps 'R' Us staff member in accordance with the camp's sun protection policy. I understand that my child may not carry sunscreen on his/her person while at camp, and that all sunscreen products must be given to the camp office. If I provide sunscreen to the camp for use by my child, I understand that it must be approved by the FDA for over-the-counter use. I acknowledge that my child uses sunscreen for the purpose of avoiding overexposure to the sun and not for medical treatment of any injury or illness. **In case of emergency:** In the event that parents, guardians, emergency contacts, other authorized adults, or a family physician cannot be contacted in an emergency, Camps 'R' Us, New York LLC is granted permission to provide whatever medical attention is necessary and/or to take my child to the nearest available hospital's emergency room. I hereby give my consent to Camps 'R' Us, New York LLC to arrange for emergency medical/surgical/dental care and treatment (including diagnostic procedures) necessary to preserve the health of my child, and acknowledge that I am responsible for all charges associated with any such care and treatment rendered.

Camps 'R' Us, New York LLC is required to be permitted to operate by the Nassau County Department of Health and as such is required to be inspected twice yearly. Camps 'R' Us, New York LLC is required to be permitted to operate by the Suffolk County Department of Health Services, and as such is required to be inspected twice yearly. Inspection reports are filed at the Suffolk County Department of Health Services, 3500 Sunrise Highway, Suite 124, P.O. Box 9006, Great River, NY 11739. Inquiries can be made Monday-Friday, 9:00 AM-4:45 PM.

This enrollment agreement constitutes the full understanding of the parties hereto and no change, modification or waiver of any of the terms shall be effective unless in writing and signed by both parties. The person who accepts and signs this camper application/contract represents that he/she has full authority to do so and will be responsible for payment of all camp fees. In the event that this enrollment agreement is executed by one parent/guardian, the undersigned acknowledges that he/she is also acting as agent of any other parent/guardian with authority to enroll the child at camp and to execute the enrollment agreement on his or her behalf. In addition, this undersigned has read and fully understands the information presented in the Camps 'R' Us Parent Guide, available at [campsrus.org](http://campsrus.org) or by calling (877) 850-2267.
